JA AREA IMPLEMENTATION GUIDE

The Take Our Daughters And Sons To Work Foundation and Junior Achievement are joining forces this year for Take Our Daughters And Sons To Work Day on April 25, 2024.

Since 1993, on the fourth Thursday in April, more than 40 million youth and adults in over 4 million workplaces around the world have participated in the Take Our Daughters And Sons To Work (TODASTW) program. This year, using the theme "Inspire 2 Aspire," TODASTW and JA are partnering to connect children to employers for a real-world work experience. Outreach also includes historically disenfranchised students such as foster children, youth at high-risk of dropping out of school, or youth who may not have a parent or guardian whose job will allow them to bring children to work.

Additional resources are available within this implementation guide for JA Areas to coordinate communications and planning between companies participating in Take Our Daughters And Sons To Work Day and the schools and students attending the event.

Sample Communication to Schools

FAQs

Q: When is Take Our Daughters And Sons To Work Day?

A: April 25, 2024

Q: When does the day begin and end?

A: The coordinating company determines the start and end times.

Q: How are students transported to and from the company?

A: Students typically arrive at the company and leave at the end of the day with their parent, guardian, or sponsor.

Q: Why is Junior Achievement partnering with Take Our Daughters And Sons To Work Foundation this year?

A: Junior Achievement and the Take Our Daughters And Sons To Work Foundation are partnering to connect children to employers for a real-world work experience.

Q: Do students need to complete any forms prior to attending Take Our Daughters And Sons To Work Day?

A: A sample excused absence form is available in this guide. The school and the participating company determine the requirement for this form.

Q: If a student is not able to attend Take Our Daughters And Sons To Work Day with a parent or guardian, what are our options?

A: Another adult can sponsor a student who is unable to attend the event with a parent or guardian. The sponsor could be a friend's parent or guardian, another family member, etc. The sponsor is responsible for coordinating the student's transportation to and from the event and ensuring their safety.

Q: What types of activities will students participate in during the day?

A: Students will participate in activities surrounding this year's theme, "Inspire 2 Aspire." Students will also have the opportunity to speak with employees of the company and interview them about their work experiences.
