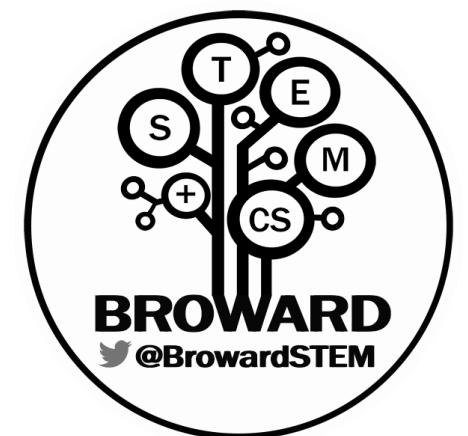

**Mission:** To reach our diverse population with a diverse portfolio of STEM opportunities, assuring that STEM is for ALL students.

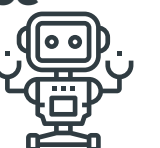

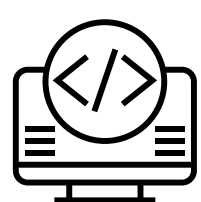

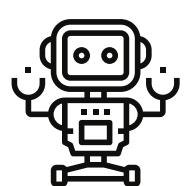
