## Outreach Services Information

### Child and Family Therapy

#### **Individual Therapy**

Individual Therapy helps children process strong emotions and feelings. Children are encouraged to grow, resolve underlying issues, gain a better understanding of current feelings and emotions, and process tough experiences.

#### **Family Therapy**

Family Therapy helps family members gain a better understanding of how domestic violence has impacted the family, increase positive ways to cope, build healthy communication, and create an overall better functioning home environment.

#### **Infant and Early Childhood Therapy**

Infant and Early Childhood Therapy focuses on supporting and strengthening the relationship between a child and his or her parent (or caregiver) in order to repair the child's sense of safety and attachment and ultimately improve the child's cognitive, behavioral, and social functioning.

#### **Therapy Treatment Models**

The Child and Family Therapists use the following approaches and models of treatment to help children heal from Domestic Violence: *Play Therapy, Art Therapy, Trauma Focused Cognitive Behavioral Therapy, and Child Parent Psychotherapy*

### Family Advocacy

#### **Individual Counseling Services**

Counseling helps children cope with environmental and emotional stressors. Children are empowered to find solutions to specific problems.

#### **Individual Parenting Sessions**

Parents/caregivers will be provided with support and guidance.

#### **Resources and Referrals**

Parents/Caregivers will have the option to meet with an advocate to obtain information on community resources and referrals. Advocates can provide case management assistance and are also able to provide emotional support during family and criminal court cases.

### CPI Project

#### **Co-Locate Domestic Violence Child Welfare Advocates**

The CPI Project consists of a team of advocates that are co-located at the Broward Sheriff's Office Child Protective Investigations Section and at ChildNet.

**Goal:** The ultimate goal of the CPI Project is to bridge the gap between child welfare and domestic violence service providers by reducing barriers, enhancing family safety, reducing removals of children from the non-offending parent/caregiver, and holding the batterers accountable for the violence and abuse that occurs.

**Services:** Court accompaniment, individual support sessions, advocacy, case management, and information on referrals and resources

### Children's Enrichment Center

#### **Respite Care**

Respite Care provides a safe environment for children to learn, grow, and feel loved and supported while parents attend groups, therapy, and advocacy services.

#### **Hours:**

### Adult Therapy

#### Individual Therapy

Individual therapy helps survivors of domestic violence process difficult feelings and traumatic experiences, while providing them with the tools and skills to effectively cope and manage strong emotions. Therapy helps to promote personal growth, development, and empower survivors to become proactive about the changes they desire and work toward autonomy.

#### Therapy Treatment Models

The Adult Therapists use the following approaches and models of treatment to help clients heal from domestic violence: *Cognitive Behavioral Therapy, Solution-Focused Therapy, Mindfulness, EMDR, Traumatic Incident Reduction Therapy, and Motivational Interviewing*

### Adult Advocacy

#### Individual Counseling Services

Advocates are available to provide ongoing emotional support, guidance, and safety planning.

#### Resources and Referrals

Advocates are available to provide advocacy, information on community resources and referrals, and case management assistance.

#### Victim Compensation and Relocation Assistance

Survivors of domestic violence who have a domestic violence law enforcement offense report may qualify for victim compensation and/or relocation assistance through the state. Advocates are available to meet with survivors to complete the application process.

\*\*\*Only Certified Domestic Violence Centers can complete the relocation section of the application with survivors.

### Court Advocacy

Women In Distress's Court Advocacy program assists clients in safely participating in the legal system by providing support and information throughout the process.

**Services:** Court accompaniment, assistance with domestic violence injunctions for protection, family court, and criminal court cases and information on community resources and referrals.

### InVEST

#### Coordinated Community Response

The InVEST (Intimate Violence Enhanced Service Team) Advocate works closely with law enforcement to ensure domestic violence, dating violence, sexual assault, and stalking incidents are treated as serious violations of criminal law requiring the coordinated involvement of the entire criminal justice system. The InVEST Advocate reviews all domestic violence related police reports within the county in to determine potential high-risk domestic violence cases and to make contact with survivors to determine if they are interested in participating in the program.

**Goal:** The InVEST project provides a coordinated community response effort intended to reduce the number of intimate partner homicides in Broward County.

**Services:** Court accompaniment, individual support sessions, advocacy, case management, and information on referrals and resources

### Economic Justice Program

The Economic Justice Program provides training, information and resources to address the economic conditions that create barriers to the long-term independence, and safety of survivors and their children.

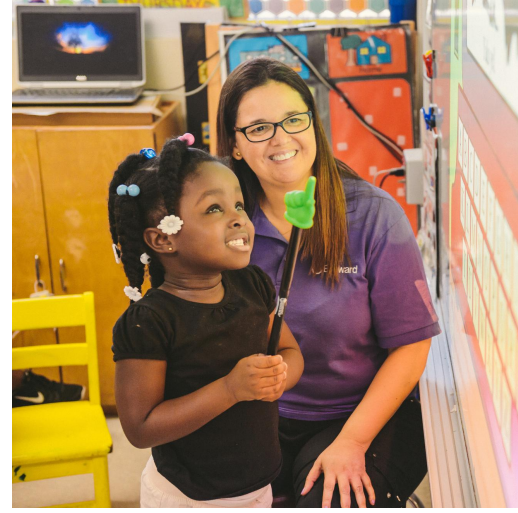
**Services:** Resume Writing, Financial Stability, Assistance with searching for a job, Interview Coaching, Dress for Success, Computer Classes, ESOL Classes, Credit Repair

### Injunction for Protection Project (IFP) – Restraining Orders

The IFP Project Attorneys provide free legal advice and or representation to survivors of domestic, dating and sexual violence or stalking.

**The Services Include:** 1) meeting with survivors to provide legal advice to determine whether seeking an injunction is a safe and appropriate; 2) completing and filing petitions and representing survivors at final injunction hearing; 3) representing survivors who has obtained a temporary injunction order at the final injunction hearing; 4) represent survivor who has a final injunction at a civil violation hearing; and 5) defend survivors in hearings where the abuser is attempting to dissolve the final injunction order.
