98.2% of students were reached Chart shown to show growth of 57.6% for AP 1

Now, 50% of students are on-track.

Grades 3,4,5 – Only students who are struggling or meet certain criteria are tested.

ESE Students – SIP Plan goal – 19 students maintained and 18 increased 2 or more letter levels.
