

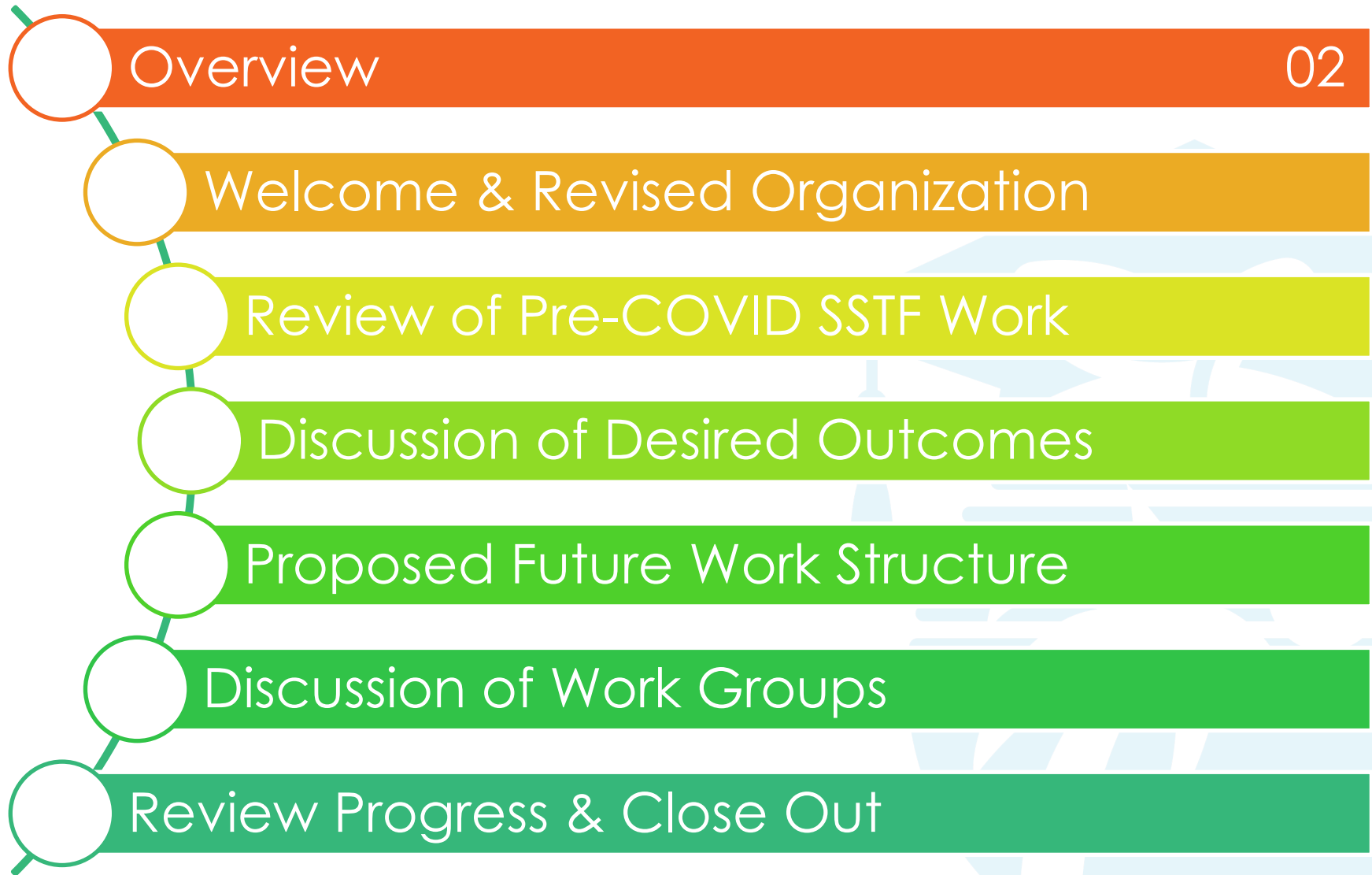

- Final Report to Superintendent in March 2022

Related Timelines

- General Operating Budget: February – June 2022
- Organizational Staffing Design: March – May 2022

- Policy Revision & Adoption: At least eight weeks
- Anticipated Vote for Renewal of Referendum: August 2022
- Start of Fiscal Year: July 1, 2022

Dec 2019: SSTF MTG1 – commencement

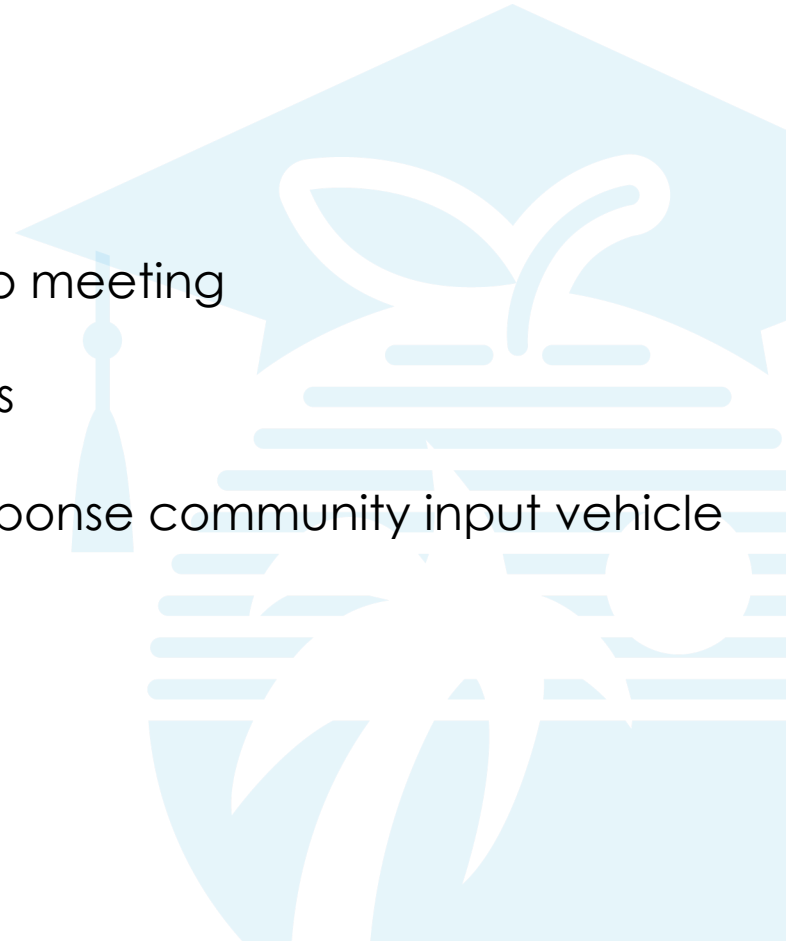
Jan 2020: Issuance of resource document

Recommendations for improvements

- Changes to current practices, procedures, policies
- Potentially new initiatives
- Resource realignments and asks



Proposed Future Work Structure

Whole Group

- Meet Monthly
- Dec → Data dives & policy/procedure questions
- Jan → Separate what is working and what needs recommendations
- Feb → Review Draft and recommend improvements
- Mar → Finalize and submit to Superintendent

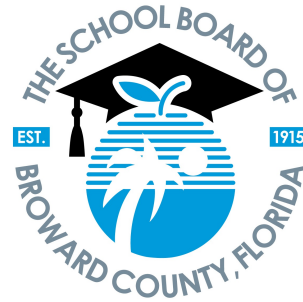
