1. Harvest Drive

- Glades MS collected over 1,600 items.
- Additional funds available to purchase items for families in need.

2. Title I Update

- Glades MS was grandfathered in for the current year.
- Current eligibility is at 42.36% as of October 28.
- Next system update: January 6, 2025. Goal: 50% eligibility by February.
- Ms. Mentor reaching out to see if maybe our Title One Support Facilitator, is able to give us weekly updates so that we can see if we can incentivize it for the kids.
- Title I funding of \$333,000 supports teachers, parent involvement, and school operations.
- The Parent Family Engagement Survey is available on the school website. A 10% community participation rate is required.
- Letter was sent home for parents to sign and verify.
