VIII. Meet and Greet/Activities



- The school is currently handling re-assignments. This event will help increase student enrollment.

#### IX. Scheduling and Parent Links

- The Canvas module for elective courses will allow rising students to see class recommendations. Students will not be able to select courses but can view recommended classes.

#### X. Course Selection and Back-up Options

- On April 7th, students will log into Focus to choose two electives and a back-up. Peer counseling will assist with this process.

#### XI. Make-Up Day

- April 11th will be a make-up day. Reports will be reviewed to ensure students made their selections. After this date, students will be placed in available courses.

- Rehearsals are every Thursday with peer counseling for preparation. The event is scheduled for April 17, 2025.

#### XIII. Science Assessments

- Ms. Daniels reports that last week's biology assessments went well. The BSA was administered two weeks ago.
- Additional assessments and extra help will be provided during Spring Break (ELO plan). Extra help will be available on Thursdays, focusing on 8th-grade standards.

#### XIV. School Behavior Plan Discussion for Next Year

- The behavior plan for next year is under discussion. Any suggestions should be directed to Mr. Kosis. The floor is open for comments.

#### XV. Concessions and Custodial Needs

- The concessions area needs to be moved to the front. Custodial staff needs to clear the area.



#### XVI. Kosis Courtyard Transition Issues

- The current internal suspension setup in the courtyard is not effective. It appears to turn into a reward for students, providing them with a free period. There needs to be a better plan for these transitions.

#### XVII. Class Coverage and Disruption

- Some students do not have activities during class coverage. IS students are causing disruptions in the area, and it's not beneficial to have both groups in the same space.

#### XVIII. Parent and Staff Interaction

- Parents should not be turned away. If a staff member is absent, the student is sent to Mr. Kosis, along with the IS students mentioned earlier.

#### XIX. Security Staffing

- The school is not fully staffed, and Mr. Kosis fills in for absent teachers, IS students, and security duties in the hallways.

#### XX. Top 3 Incident Locations

- Incidents are most frequent in hallways, classrooms, campus grounds, and the bus loop. It's essential to display rules in these areas, and PBIS funding will be used to ensure that rules are visible next year.

#### XXI. Behavior Plan and Rewards

- We need funding to provide rewards for good behavior. A short-term goal is to implement a pilot group to test this initiative.

#### XXII. Student Recognition

- Students will be recognized during lunch. Mr. Kosis has a plan for PBIS that includes cost-effective ways to reward students.

#### XXIII. Student Improvement Line Item

- This line item is running for the 4th period.



#### XXIV. Behavior Tracking System

- A data tracking system for high-flyer students will be used. RTI (Response to Intervention) and family counseling are recommended, although not always accepted by families. We will continue to follow up.
