





December 5, 2024 (5th meeting of the year)**

Welcome - A meeting of the Sandpiper School Advisory Council was held in the Media Center and via Teams on Thursday, December 5, 2024.

Ms. Swickle called the meeting to order at 2:15 pm.

Laurel R-Love will record the minutes for this meeting.

Attendees – The sign in sheets and Teams attendance will be attached to the minutes. Please note 17 SAC committee members attended (16 in person).

Quorum met.

New Business – New Officers

Ms. Jehaludi nominated Gabriel Osman to I-Zone representative and ESOL representative, and Francis Picado to ESE representative. Ms. Sturgess seconded. Floor opened for discussion. Floor closed. Motion passed unanimously.

Ms. Valmont nominated Noeliss Madera and Dr. Michelle Gomez to be teacher representatives. Ms. Delsalle seconded. Floor opened for discussion. Floor closed. Motion passed unanimously.

Ms. Swickle reviewed the SAC membership and composition. Membership approved and voted in the current membership.

Approval/corrections to minutes

– Ms. Swickle presented May 16, 2024, minutes. Ms. Valmont motioned to accept the minutes as written. Ms. Delsalle seconded. Floor opened for discussion. Floor closed. Motion passed unanimously.

– Ms. Swickle presented August 29, 2024, minutes. Ms. Valmont motioned to accept the minutes as corrected. Ms. Delsalle seconded. Floor opened for discussion. Floor closed. Motion passed unanimously.

– Ms. Swickle presented October 2, 2024, minutes. Ms. Valmont motioned to accept the minutes as corrected. Mr. Gurk seconded. Floor opened for discussion. Floor closed. Motion passed unanimously.

– Ms. Swickle presented October 24, 2024, minutes. Ms. Sturgess motioned to accept the minutes as corrected. Ms. Valmont seconded. Floor opened for discussion. A+ funding proposals will be revisited at today's meeting. Floor closed. Motion passed unanimously.

– Ms. Swickle presented November 7, 2024, minutes. Ms. Sturgess motioned to accept the minutes as corrected. Ms. Valmont seconded. Floor opened for discussion. Accountability funding will be revisited at today's meeting.

Floor closed. Motion passed unanimously.

SAC Bylaws – Ms. Swickle

Ms. Swickle presented the SAC bylaws. Ms. Sturgess motioned to accept the minutes as presented. Ms. Valmont seconded. Floor opened for discussion.

Floor closed. Motion passed unanimously.

A+ Funding – Ms. Swickle

Ms. Swickle presented 9 options for the A+ funds dispersal. Funding options, limitations, and voting rules were presented. Members and non-members present were granted time to discuss the options and air opinions. Roll was called and each member present voted for two of the options. (roll call voting list is attached).

The two options with most votes (each received 7 votes) were:

Option #3 - 5% of the shares go towards temporary personnel for tutoring for students in need. The remainder equal shares for all Instructional and Non-Instructional staff.

Option #4 – Equal shares for all Instructional and Non-Instructional staff.

Ms. Jehaludi motioned the ballot to include Option #3, Option #4, and none of the above. Ms. Sturgess seconded. Motion passed unanimously.

Accountability Funds – Currently, Sandpiper has \$1,178.48 in accountability funds. Ms. Valmont motioned to spend the funds for 1st Grade Scholastic magazines \$469.26 and to partially fund Accelerated Reader \$709.22. Ms. Smith seconded. The floor was open for discussion. Parents expressed concern about other grades using Scholastic magazines. Floor closed. Motion passed unanimously.

SAC information and updates – Ms. Swickle

Students are currently testing. Results will be discussed at the next SAC meeting.

Focus and Clever Navigation – Dr. Gomez

Dr. Gomes presented a “how to” navigation through Focus and Clever for parents. Suggestions made to post the presentation on the Sandpiper website, and to hold a technology night next year for new parents.

Principal Updates & Upcoming Events – Ms. LaChance

Testing begins. Students are challenged to *Meet It & Beat It!* Students surpassing the previous testing results will be invited to a Dance Party (with snacks) during school on December 20th.

As part of our Life Skills and Wellness School Counseling plan, our students can participate in the SAVE club with Ms. Himmelsbach. Students Against

Violence Everywhere (SAVE) Promise Clubs is a student leadership initiative by the Sandy Hook Promise Foundation that aims to cultivate and bolster student leaders to take an active role in increasing school safety and preventing different forms of violence in schools and communities.

Our school guidance counselor, Ms. Codd, facilitates counseling groups for students who have been retained, students experiencing grief, and students whose families are experiencing divorce.

Our school social worker is conducting the county wide toy drive – boxes are in the front office for toy drop offs.

The Harvest Drive went very well. Sandpiper families in need received boxes of groceries.

Speakers have been bought and installed in the cafeteria for better sound during family and school events.

Option 9:

Full shares for Classroom Teachers, Educational Support Staff
(Paraprofessionals), Clerical, Support Staff, Micro-Tech, Cafeteria and Custodial
staff.

Note:

If no proposal or (None of the Above) receives the majority vote, then new proposals will be drafted and voted on. If no majority is reached on a proposal by the February 1st deadline, the A+ funds will be equally distributed to all full-time classroom teachers currently teaching at the school. A full-time classroom teacher is assigned to a classroom with students on a daily basis.

To be eligible for A+ bonuses, employees must have been full-time, permanent employees, present for at least 99 days during the 2023-2024 school year at Sandpiper Elementary.
