Flexible Parent Meetings

Game Day meets once a week for one-hour and features fun and exciting games as well as lessons which teach students character values from a biblical perspective in a safe and enriching environment. Game Day offers our 3rd-5th grade students fun game time and snacks, faith-based character value lessons, gospel presentations and invitations, and an opportunity to attend faith-based activities outside the school on weekends at local parks.
