Violation #13. Food in good condition, safe, & unadulterated

Canned food (Diced Peaches) with dents on hermetic seal, food adulterated. Remove dented can/provide intact canned food with no dents on hermetic seal. Corrected Onsite. Dented can removed.

CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.

Violation #21. Hot holding temperatures

Hot TCS food (Ham and cheese Sandwich) tested 121 F, not held at 135F or above. Reheat foods at 165F/Reheat commercial product at 135F or above. Corrected Onsite. Reheated to 165 F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #54. Garbage & refuse disposal

Dumpster drain plug missing, wastewater draining out of dumpster. Replace drain plug

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

Violation #55. Facilities installed, maintained, & clean

Observed ceiling tile around vent in disrepair in dry storage area. Work order # 787466 placed on 09/11/2023

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
