1	Title I	The district coordinates with Title I, Title II, and Title III in ensuring staff development. Meetings will be facilitated throughout the school year to provide essential information to parents about their child's progress. Parents will be included in the decision-making progress for all Title I funds. In addition, services are coordinated with the district Dropout Preventions Programs.
