# Principal – Robert Pappas

• Congratulate everyone on a successful year last year. We had a record-breaking academic year across all departments. Which is a compliment to both the staff, students, and the parents. This year has been a whirlwind, there has been a lot with the new testing, two hurricane days, power outages, fire drills, etc. Hopefully, we will have less disruptions between now and the end of the year.

This year for the first time the staff is going to vote as to whether we move to a block schedule for next year. We will be having a conversation as to the pros and cons. The first vote will be if we even want to consider the move. If more than 66 2/3 of the staff vote no, it stops right there. If the vote is yes, then we have a deeper conversation and move on to a second vote. If it passes it will be for a two-year commitment. This is strictly a staff vote and Mr. Pappas does not have a stake in it. Part of Mr. Pappas's job as a leader is to inform the staff effectively. Some teachers like the block because they think they can make more money; some do not like it because they do not want to teach a 90-minute session. Those are valuable reasons but are not good enough, those are surface level thinking. His job is to give more detail and more examples and show the teachers how it is going to impact them and obviously most important is to consider the children. This is a four-by-four block, which is an A-day and a B-day. Students would have eight classes, four on A-day and four on B-day. On a block a student could have four core and four electives.
