Violations Comments

Violation #39. No Contamination (preparation, storage, display)

Commercially made pre-packaged food item (salad dressing) held inside clamshell takeout plastic container in contact with RTE chopped salad and tomatoes. Protect food by use of packaging, or other effective means as removing pre-packaged dressing from plastic takeout container.

CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.

Violation #44. Equipment & linens: stored, dried, & handled

Improper storage of clean utensils (scoops). Align all handles to same direction to avoid cross contamination. Corrected on site, items properly placed.

CODE REFERENCE: 64E-11.003(4). Utensils and equipment must be cleaned, sanitized and air dried prior to storage. Utensils, equipment, and linens must be properly cleaned and stored.
