Students' hours are: 8:00 a.m. - 2:00 p.m. Office and teachers' hours are: 7:30 a.m. - 3:00 p.m. Breakfast time is: 7:15 a.m.- 7:45 a.m.

Arrival Procedures

- Car drop off is in the front of the school, students should not be dropped off in the bus loop or in the staff parking lot.
- Pre K , Headstart and ASD students will have teacher assistants in the car loop to assist them to their classrooms.
- Staff members will be on post to supervise students at 7:30 am.
- Students must not be dropped off before 7:15 am and that's only if they will be having breakfast.
- Students who arrive to school after 8:00 a.m must be escorted into the building by their parent(s) and signed in. Parents must have a valid ID.

Dismissal Procedures

Car Riders

- Parents will be issued a mirror sign with student's name and grade.
- Please hang sign on mirror while in the car pick up loop. Stay in your vehicle and wait for staff members to put student in the car.
- Car Riders will be in their classrooms.

Walkers

- Front walkers will exit from the front of the school.
- Back Walkers will exit through the back gate of school on 43rd Ave.
- Parents must wait at the bike rack.
- No parents are allowed to walk through students sitting in the car rider area.

Please note!!!!

- Any changes to student's normal dismissal must be done prior to 1:15 pm.
- No student can be signed out early after 1:30pm.

Arrival

Bus Riders

- Students will be escorted to bus area by a staff member.
- All Broward County School bus riders will load the buses in the bus loop.
- Day Care Buses will enter from 43rd Ave in the back of the school. Students will be loaded by staff.

After Care Students

 Students will be escorted by designated staff members to the cafeteria.

Rainy Day

- Discuss with your students their rainy-day plan.
- Please Note students who are walkers will not be dismissed during torrential rainfall or thunderstorms.

Complete Student Dismissal form in first day packet that addresses rainy day.

Uniform

- Plantation is a <u>mandatory</u> uniform school. The uniform colors are red, white, light blue and navy-blue collared shirt and navy, black and khaki bottoms.
- Students must wear uniform to school every day. On Fridays students are allowed to wear school t-shirts and jeans. School shirts are available at the school for \$10.00.
- Students will need school shirts for off campus field trip.
- Failure to wear uniform to school will have consequences.

RAPTOR

All visitors to the school are required to be processed through the RAPTOR System. Please make sure you have a picture ID when visiting campus. Only contacts on your emergency dismissal list will be able to sign your child out. If you are sending a contact from your list, please make sure they have a picture ID. If for any reason you need to send someone one not listed on your Emergency Dismissal Form , you need to inform the school in writing.

FORTIFY FL TIP REPORTING

The safety and security of our students, staff and schools remain the highest priority for Broward county Public Schools (BCPS). The Division of Safety, Security and Emergency Preparedness would like to take this opportunity to remind everyone of the anonymous tip reporting resource FortifyFL and the responsibilities of each school based on Florida Statute.

Section 943.082 (4b) of Florida Statutes states: "The district school board shall promote the use of mobile suspicious activity reporting tool (FortifyFL) by advertising it on all the school district's website, in newsletters, on school campuses, and in school publications, by installing it on all mobile devices issued to students, and by bookmarking the website on all computer devices issued to students."

The FortifyFL app, from the State of Florida, allows individuals to instantly report suspicious activity to appropriate law enforcement agencies and school officials. By accessing FortifyFL, anyone can provide a description of a potential threat, share pictures and videos. Submitting a tip is quick and easy using the mobile app or website. FortifyFL is a free mobile phone application that is available in the Apple App store and Google Play Store.

Please remember the purpose of this tool is to report unsafe, potential harmful, dangerous, violent, criminal activity, or the threat of these activities, to the appropriate authorities. Submissions go directly to school administrative staff, District officials, as well as law enforcement agencies and will be investigated appropriately.

When submitting a tip, please remember to include as much details as possible, such as social media handles, images, dates, times or other relevant information that will assist investigators.

Note that this method of reporting is NOT a replacement for calling 9-1-1, when there is a crime in progress or an emergency.

BCPS encourages everyone to be vigilant in reporting all suspicious activity to the appropriate authorities, regardless of your preferred method of communication. Providing contact information is optional.

Working together, we can improve the safety in schools and our community.


