SUBJECT: 2010-11 TENTH DAY STUDENT MEMBERSHIP COUNTS

The tenth day student enrollment, including both District and charter schools, is 256,097 as of Friday, September 3, 2010. District enrollment is 233,043. This represents a decrease of 1,318 from last year's tenth day enrollment. Charter school enrollment is 23,054. This represents an increase of 2,566 from last year's tenth day enrollment.

Table 1 presents a comparison of last year's and this year's tenth day enrollments at District Broward County public prekindergarten, elementary, middle, high and center schools, as well as charter schools. This student enrollment count includes all prekindergarten through twelfth grade students who were in attendance at least one day and have not withdrawn.

Historically, tenth day enrollment has closely aligned with twentieth day enrollment and this year follows that trend with the tenth day enrollment being slightly greater (100.2%) than the projected twentieth day enrollment as shown in Table 2. District staff anticipates that there will be little difference between the tenth and twentieth day counts.
